Since the Hospital has changed its internal response level from Gray to Red, and the province-wide stay-at-home order has ended, Senior Leadership Council (SLC) has approved several Volunteer Services (from stage two of the Recovery Plan) to return to on-site service effective immediately. These include Surgical Day Care Volunteer, Cancer Centre Volunteer, Ambulatory Care (Bundles) Volunteer, Endo/SDC Chart, Pre-Admission Volunteer, and OR Liaison Volunteer (OR Family Waiting Area).

In addition to these roles, SLC also approved that Adult Mental Health Volunteers return to on-site service, as well as a new Vaccination Clinic Volunteer role to assist in the Vaccination Clinic located at the Bora Laskin Building. As per the Provincial Roadmap to reopen, SLC also approved the re-opening of Seasons Gift Shop and returning Gift Shop Volunteers. Seasons Gift Shop is scheduled to reopen to customers beginning on July 5th, weekdays from 9:00 am to 4:00 pm. We're excited to welcome back these dedicated volunteers who make such a difference for patients, family members, and staff.

Our Hospital's COVID-19 Vaccination Clinic is receiving an additional vaccine allocation to allow for some staff to reschedule their second dose appointment at an earlier date. If you received your first dose on or prior to April 18th and wish to reschedule your second dose appointment, please do so by using this link: https://tbdhu.canadaehs.com/tbdhu/hospital/.

If you reschedule any appointments, please ensure you cancel your original appointment so that your spot is available for another individual. If you need to cancel an appointment at the Hospital's COVID-19 Vaccination Clinic (Bora Laskin building) you can do so in person when you attend the clinic or by email at vaccinationclinic@tbh.net only if you will not be attending the clinic. While appointments are somewhat limited, it is expected that additional appointments for the weeks of June 14th and June 21st will be available in the next several days as additional vaccine supply is confirmed.

You may now access your own vaccine receipts through the provincial booking system at https://covid-19.ontario.ca/book-vaccine/. Proceed as if you are booking an appointment. You will need to provide your health card number, date of birth and postal code. Once this is entered, there will be an option to book an appointment and an option to access your vaccine receipt.

Our Hospital is participating in Accreditation Canada's on-site survey from May 16-19, 2022, and will be evaluated on 19 evidence-informed standards, and three surveys which include the Canadian Patient Safety Culture survey, Worklife Pulse (including physician version) and Governance Functioning tool.

The Canadian Patient Safety Survey (Can-PSCS) tool is completed by staff providing direct care for patients. Approximately 467 clinical staff, including Professional staff, completed the survey. This tool is used to evaluate staffs' perceptions of how the organization approaches patient safety and reports safety incidents.

The Quality and Risk department is taking the lead to address concerns raised by staff. An *Expression of Interest* will be sent to staff to participate in a working group (June to September 2021) with Katherine Mayer (Patient Safety Improvement Specialist) and Keith Taylor (Patient and Family Advisor) as co-chairs. Staff will be engaged through focus groups and surveys and the feedback will inform the action plans which will be deployed in the summer, evaluated and scaled up. The results will be compiled in the Patient Safety Report, a required document to be submitted to Accreditation Canada, prior to the on-site survey.
