On Monday, December 6th, we communicated to Hospital staff about the implementation of a mandatory COVID-19 vaccination policy for all employees, credentialed professional staff, active volunteers (including Board members) and learners. As of today, we have 96.4% of staff fully vaccinated. We value every team member but we need to do what is best to protect our patients and the safety of our organization and community. Implementing a mandatory COVID-19 vaccination policy stands by our philosophy to put patient care and safety at the center of everything we do at our Hospital.

Our Hospital is part of a regional approach for a mandatory COVID-19 vaccination policy with all 12 regional hospitals across Northwestern Ontario supporting a mandatory vaccine mandate which was endorsed by the Chiefs of Staff and CEOs of all 12 of the hospitals. Implementation of the policy aligns us with our partners in long-term care and over 120 other hospitals throughout the province.

Any staff who need their first, second or third dose of the COVID-19 vaccine may book an appointment with the Hospital's onsite vaccination clinic by visiting https://tbdhu.canadaehs.com/tbdhu/hospital/. Appointment dates have been extended to January 14th, 2022 to align with the first dose deadline in the mandatory COVID-19 vaccination policy. If there are Hospital staff who are hesitant to be vaccinated due to severe allergies or health concerns, they may be referred to our high-risk vaccination clinic through their primary care provider or a physician at the Thunder Bay District Health Unit (TBDHU)'s CLE mass vaccination clinic if they meet the eligibility criteria. Instructions for referral have been provided to all primary care practitioners as well as the TBDHU, along with the referral form. It is also important that we remain vigilant with hand hygiene and PPE practices in order to protect our staff, patients, and the health care system. All workers (staff, professional staff, volunteers, learners and contractors) at our Hospital are required to wear eye protection in clinical areas (inpatient and outpatient) or when providing patient care in a non-clinical area where two metres cannot be maintained. This means that when any worker enters a clinical area (inpatient and outpatient), eye protection is mandatory at all times.

Eye protection is not required or can be removed ONLY if the Hospital is in Pandemic Response Level Green or Yellow and if the worker is in a private office located in a clinical area; removing their eye protection to disinfect them; in a designated break area where distancing of two metres can be maintained; leaving the clinical area to

go on break and/or leave the Hospital; or in a non-clinical area (meeting rooms/area) and is <u>NOT</u> within two metres of a patient.

These measures enhance your safety and protect the specialized acute care services we provide to those in need.
