#### Where we are today....

- A Peer Support worker recently shared:
  - Six individuals commented to them that they received excellent, compassionate care when attending the hospital for substance use related illness
  - Peer Support Workers have seen a noticeable difference since the launch of the anti-stigma campaign
- A Patient & Family Advisor shared that they have seen a shift in the care that is being provided at TBRHSC since the campaign started
- Stigma Ends with Me- 199 people attended
  - "Through this training I gained confidence in my ability to apply a Substance Use Health approach to my work and see substance use through a Substance Use Health lens"





### **Planned Clinical Expansions:**

- Addictions Medicine Consult Team (Phase 2):
  - Team includes: Registered Nurse, Peer Support, Indigenous Navigator, Social Work, Nurse Practitioner, physician, Pharmacist
    - Awaiting funding
- Reorganization & expansion of existing Consultation Liaison Service
  - Support off service patients experiencing mental illness (patients outside of AMH, FMH & CAMHU)

#### **Related Project / Clinical Expansion:**

- Inpatient Acute Withdrawal Management Beds (4 beds)
  - ► For patients who are medically unstable as a result of substance withdrawal
    - ► Go-live in 2025





### Funding Proposals:

- Substance Use & Addictions Integrated Pathway- Application for Phase 1 site (in collaboration with SJCG) Submitted to OH
- Addictions Medicine Consult Team- Request for permanent funding for fulsome team – Submitted to OH
- ED pressures & supportive care model- will provide an enhanced care model to improve the patient experience, optimize current staffing, and promote supportive roles – Submitted to OH





#### Related Projects / Capital Renovations:

- ► Creation of a safe de-escalation space in the ED Complete
- Approved plan to re-design ED Triage and Waiting Room focus on privacy, ability to supervise, and safe spaces - In progress
- Mental Health Emergency Department- creation of dedicated space within the ED for mental health & addictions patients- capital submission to Ministry of Health (MOH) - Awaiting MOH
- Expansion of Psychiatric Intensive Care Unit (PICU) to add 8 additional beds-Capital submission to Ministry of Health- Awaiting MOH

The Substance Use & Addictions Steering Committee will have achieved its mission when:

- ► Barriers have been reduced for patients experiencing SUA to receive care
- Patients are met where they are at
- Non-judgmental care is consistently provided
